Playing Rights are available in the following categories:

- 7 Day (full playing rights 7 days per week, subject to tee time availability)
- 5 Day (playing rights Monday to Friday including public holidays, subject to tee time availability)
- 1. Playing Rights are for 12 months, are not transferable or refundable.
- 2. Playing Rights fees are payable in full by 30 September 2023.

3. Instalment payment options are available by direct debit for 7 Day and 5 Day Playing Rights. A 5% handling fee is applied to all instalment paying clients.

4. Mount Compass Golf Course reserves the right to accept or reject any application at its complete discretion.

5. Applicants must observe the Rules of Golf and maintain acceptable social standards of behavior on the Course and within the Clubhouse.

6. Applicants must observe Dress Standards as applied from time to time by Mount Compass Golf Course.

7. Mount Compass Golf Course may terminate Playing Rights for any individual for breach of these terms and conditions at its complete discretion. No refund shall be due to the Playing Rights holder in such an event.

8. Non payment or late payment of Playing Rights fees shall result in immediate suspension of Playing Rights. Any and all monies owing must be paid in full, including late payment fees, administration fees and interest prior to restoration of Playing Rights.

9. Mount Compass Golf Course cannot and will not guarantee course availability and tee times for any Playing Rights holder. There will be times when the course is unplayable due to weather conditions, programmed and emergency course maintenance and where group bookings such as trade days have been given exclusive use of the course.

10. Management reserves its rights in making the course available to play at any time.
